 - 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Love America Act of

- 6 SEC. 2. FINDINGS.
- 7 Congress finds the following:

1 (1) Since the founding of the United States, the 2 institutions of the United States of America have set 3 the worldwide standard for promoting democracy, 4 freedom, liberty, and virtue. 5 (2) Increasingly, students across the country 6 are being taught misinformation, including that the 7 principles of the founding of the United States were 8 lies from the start, that the core institutions of the 9 United States are fundamentally racist and designed 10 to propagate racism, and that it is acceptable to im-11 pute guilt to present-day individuals based on the 12 color of their skin, rather than the content of their 13 character. 14 (3) The best antidote to misinformation is the 15 truth, which is reflected in the documents relating to 16 the founding of the United States and other arti-17 facts of the United States, including the Declaration 18 of Independence, the Constitution of the United 19 States, and the Pledge of Allegiance. 20 SEC. 3. POLICY. It is the policy of the United States that students in elementary and secondary school should know the truth

It is the policy of the United States that students in elementary and secondary school should know the truth about the history and documents relating to the founding of the United States, which express the principles that unite the people of the United States, including the Dec-

3	SEC. 4. DEFINITION OF EDUCATIONAL AGENCY OF
4	SCHOOL.
5	In this Act, the term "educational agency or school"
6	means—
7	(1) an elementary school, as defined in section
8	8101 of the Elementary and Secondary Education
9	Act of 1965 (20 U.S.C. 7801);
10	(2) a secondary school, as defined in such sec-

13	to an educational agency or school that teaches that the
14	Pledge of Allegiance, the Declaration of Independence, or
15	the Constitution of the United States is a product of white
16	supremacy or racism.
17	SEC. 6. RULE OF CONSTRUCTION.
18	Nothing in this Act shall be construed to limit any
19	right of students guaranteed under the First Amendment
20	to the Constitution of the United States.
